APPLICATION INSTRUCTIONS

To apply for free and reduced price meals, complete only one application for your household using the instructions below. Sign the application and return the application to Lisa Bryda/School Lunch Coordinator, Schodack Central School District, 1477 South Schodack Road, Castleton, NY 12033.

If you have a foster child in your household, you may include them on your application. A separate application is not needed. Call the school if you need help at 518-283-4600, ext. 22. Ensure that all information is provided. Failure to do so may result in denial of benefits for your child or unnecessary delay in approving your application.

PART 1 ALL HOUSEHOLDS MUST COMPLETE STUDENT INFORMATION. DO NOT FILL OUT MORE THAN ONE APPLICATION FOR YOUR HOUSEHOLD.

Letter to Parents for School Meal Programs

Dear Schodack families:

Children need healthy meals to learn. **Schodack Central School District** offers healthy meals every school day. **2018-2019** Meal costs are as follows: Breakfast costs **\$1.25**; Elementary lunch costs **\$2.75**; Jr./Sr. High School lunch **\$2.85**. Your children may qualify for free meals or for reduced price meals. Reduced price is **\$0.25** for breakfast and **\$0.25** for lunch.

- 1. DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. Complete the application to apply for free or reduced price meals. Use one Free and Reduced Price School Meals Application for all students in your household. We cannot approve an application that is not complete, so be sure to fill out all required information. - 2. WHO CAN GET FREE MEALS? All children in households receiving benefits from SNAP, the Food Distribution Program on Indian Reservations or TANF, can get free meals regardless of your income.
