- 6. Workshop: 2009-10 Draft #2 School District Budget. Doug Hamlin presented discussion format for budget draft #2. Minor adjustments to draft. Impact of Federal stimulus money, which offset state deficit reduction. Projected tax impact scenarios with Federal stimulus money. Emerging interpretation of American Recovery and Reinvestment Act of 2009. Webinar through NYSED provides broad stroke interpretations: spend quickly, save or create jobs, thoughtfully invest one-time funds, avoid tax increases, maintain local tax effort, respond to reporting requirements. Implication for tax scenarios. Questions, comments, discussion from board members. Federal recovery funds will have to be kept segregated from all other funds with strict reporting. Contradictory requirements for the stimulus money. Application of reserves to revenue side of the budget. Timing of changes in tax assessment rolls. Administrators are voluntarily forgoing salary increases for 2009-10.
