BOARD OF EDUCATION MINUTES – REGULAR

- 1. Meeting called to order by President, Michael Hiser at 6:06 p.m.
- 2. Paul Puccio moved to enter Executive Session to discuss superintendent contract negotiations. Michael Tuttle seconded, all present in favor.
- 3. President Hiser asked everyone to stand for the Pledge of Allegiance to the Flag.
- 4. Paul Puccio moved for approval of present agenda. Victoria Adler seconded, all present in favor.
- 5. Michael Tuttle moved for approval of the minutes of regular meeting November 19, 2015, workshop meeting December 3, 2015 and regular meeting December 17, 2015. Jeanne Strazza seconded. All present in favor.
- 6. Reports:
 - Student Presentation Christine Fowler and Students: Kaelyn Kulpa, George Isbester, Alexis Tedford, Meghan Bennett, Tyler Dorn and Jenna Hoffman. Mr. Derby introduced the students and Mrs. Fowler and shared briefly about the program they became involved in after reading *A Long Walk to Water*, a book about the lack of clean water for villagers in South Sudan, a village in Africa. They shared that they are raising money for an organization called The Iron Giraffe, Water for South Sudan to help build wells to supply clean water. The Sky is Not Limited, a Wynantskill, NY based organization run by Kevin Vailey spoke to the class and shared how he is helping to build water wells in Africa as well. Students shared their Elevator Speeches, which are short speeches that summarize important information about a topic. Builders Club has started to help with collecting donations, and students are also using money from a school dance. Their efforts have raised \$812.42.
 - 2016-17 Budget:
 - Health Insurance Report Monica Kim and Marc Quinlan from Benetech, Inc. Mr. Quinlin shared the specifics of the Insurance Consortium and how a district benefits from it. Mrs. Kim explained about how the district costs are affected by retirees, insurance buyouts and insurance enrollment. Mrs. Kim shared the premiums for the plans that the district currently offers, the trends of enrollment over a 4 year period, Retiree contributions and how they affect the district.
 - Budget Presentation Mr. Horan spoke briefly about the first draft of the budget and the
 changes that can still take place. Mrs. Kim expressed that the budget process is a year round
 process, through the year Administrators are always reviewing and looking for ways to
 improve the current budget and plan for the future. She shared and commented on an

annual timeline for budget planning and the goals that are used in planning a budget. She informed the board of current budget facts that will affect the budget, such as, ERS and TRS will have slight decreases in their rates, health insurance will increase, CPI will be .0012%, and that the district has lost debt which reduces building aid. She said that there is a large push to restore Gap Elimination Adjustment (GEA). There was discussion about how much of the early projected increase in budget is mandated and how much is program enhancements.

- 7. Meeting open for public discussion: Mary Yurista asked about the health insurance for retirees and asked how Medicare affects their health insurance? Mr. Puccio explained that the way it is setup, it is a mathematical formula to keep things steady.
- 8. Board discussion:
 - New Policy Process Mrs. Kim explained to the board the process we are undertaking to redo our district policies.
 - Tax Freeze Rebate Mrs. Kim shared that rebate checks are being mailed and some residents have received theirs.
 - Additional meeting in February board discussed that they will hold an additional meeting on February 25, 2016.
 - State Aid Mrs. Kim shared that the state aid runs are in and a printout is in the board folders for review.

Mr. Horan shared that the Kiwanians will be having their Chicken Barbecue on Sunday, January 31, 2016. He also shared that the Chinese students will be in the area starting January 31, 2016, and will have a reception that night at Tech Valley High School. Students will then be visiting local schools, and touring the capital throughout the week. Mr. Horan also talked about a problem with the roof at the high school that was discovered, he wanted everyone aware that there will be a crane on the grounds to begin repairs to the roof. Mr. Horan shared thank you letters that were sent to faculty members for their hard work, and to the residents that donated money for each student at CES to receive an autographed book from Chris Grabenstein. Mr. Chevrier also extended thanks to the entire elementary school faculty and staff for the work that was put into preparing for the visit. Mrs. Strazza talked about a weather van that was donated by Curtis Lumber to News Channel 10. She shared that they are willing to visit schools and air a weather forecast from the school.
