- 1. Meeting called to order by Board President, Michael Hiser at 7:35 pm.
- 2. President Hiser asked everyone to stand for the Pledge of Allegiance to the Flag.

- 5. Reports:
 - 1. Graduation Rate and Assessment Results Ron Agostinoni presented to the board the different types of diplomas a student can receive, and the variables that affect the graduation rate. He showed a diagram of the number of credits required to receive an advanced regents diploma. The overall graduation rate for local, advanced regents and regents diplomas is currently at 92% for the 2011 Cohort (Cohort = students 2011 through 2015). There was discussion about what the district can do to prevent students from dropping out. Mr. Agostinoni assured the board that the district does everything to try to help struggling students in an attempt to prevent them from dropping out. There was discussion about the new state passing rate for Math and ELA for the current 6 grade students once they reach high school, passing for math regents will be 75 for ELA passing will be 80. There was discussion about what the district is doing to prepare students to achieve these grades.
 - 2. 2014-15 Athletics Review David Austin shared with the board the accomplishments of the school athletes and different areas of community service that many athletes have participated in. He also shared some of the Alumni that participate in sports teams in college. He talked about the various ways the Athletic department communicates with the community including something new, The Cube which streams sporting events live. He expressed his appreciation for the Athletic Booster

Club and what they do for the athletic department in Schodack and shared a few of the things the club has given the district: Volleyball net, customized pop up tent, lobster machine, ball machine for tennis and an LED Scoreboard. He explained the new Advanced Athletic Process for sports teams and what the changes are from the old Selective Classification. Mr. Grandinetti acknowledged the good work Dave has done since he began the position and asked about ski club and if he could get the numbers for ski club participation.

- 6. Meeting open for public discussion: Mr. Horan introduced Jen Cannell from Questar, she is a school library doctoral Candidate, and is doing an internship here in Schodack. Mr. Chevrier spoke of Jen Cannell's part in having Author, Kwame Alexander visit the school last year and thanked her for her help. He expressed that she played a big part in getting Mr. Alexander to this area. 3. Presentation on Alternative Veterans' Exemption: Monica Kim explained legislation related to the Real Property Tax Law 458-a – Veterans Alternative exemption. She explained the procedure that needs to be followed and time frame of the exemption process and when the exemption would take effect. She further explained alternative exemptions that the board could decide on. She expressed that the value based on the basic exemption that would shift to non-veteran taxpayers would be \$127,076. Mr. Puccio asked for clarification of the amount that could shift to non-veteran taxpayers. Mr. Charsky asked about the impact on the Tax Cap, Mrs. Kim explained that it would have no effect on the tax cap. There was a request for clarification of the step: A hearing on the Basic Exemption takes place first, if it is no passed or tabled then the remaining hearings don't take place. If it is passed, then public hearing #2 would take place and so on through public hearing #4. There was further discussion about the tax freeze refund and whether the exemption would affect the veterans

There was concern over what could happen if other groups ask for exemptions, such as the fire departs, police agencies and EMT's. There was discussion about the possibility of a straw vote from the public to see what they feel, but it was suggested that the community would pass a straw vote and therefore, there is no need to wait until May. Jeanne Strazza discussed the district's handling of their finances to get through tough budget years, and felt that a public straw vote might be what the district should do. Chris Olsen expressed that it will not affect the running of the district but will affect the amount that people pay in their taxes.
