Frequently Asked Questions

What is Equine Assisted Growth and Learning?

It is an experiential learning model designed to allow clients to learn and grow from the horse-human relationship. The focus is on moving and participating in activities with the horses.

Why Horses?

Horses are especially attuned to our emotions and intent. Because of their sensitivity, we can work with them to solve problems in symbolic terms in the arena. They respond to us with a high level of perception, providing experiences that help us grow, learn and heal.

Will I need to ride the horses?

No, all the work is done on the ground in the enclosed arena. Participants will use props that may include hoops, noodles and cones to create the activities for the horses.

Do I need to have previous experience with horses?

No, not at all. For this kind of work with horses, you just need to "be yourself" and be open to learning from yourself and the horses. Your facilitators will answer any questions you may have about the horses.
