#### 1. MEETING OPENING

- A. President Shelley Palmer called the meeting to order at 6:02 pm.
- B. President Shelley Palmer asked everyone to stand for the Pledge of Allegiance to the Flag.
- C. Mary Yurista moved for approval of the Present Agenda, Sherri Gibson seconded, all present in favor.
- D. Mary Yurista moved for approval of the Minutes of the October 21, 2021, regular meeting, Tylea Gebbie seconded, all present in favor.

#### 2. REPORTS

A. Capital Project - Synthesis Architects, LLP: Jim Graham and Beth DiBattista; Schodack CSD: Jason Chevrier and Brian Carey

The board was given a presentation for a proposed capital project. Work is being proposed at each of the three district buildings based on two priority groups. Conversation will continue into the new year, decisions will be made at a later board meeting of the work that will be included in a capital project.

#### 4. BOARD DISCUSSION

Daniel Grandinetti wanted to know the board's appetite to go for a higher capital project amount to include more items.

Brian Carey will look into the cost to taxpayers for a higher capital project amount.

Jason Chevrier explained the background for a possible revision to the resolution on the agenda for athletic testing of athletes of high-risk sports. There was question and concern from some of the public at the last meeting of only testing unvaccinated athletes. He recommended amending the resolution to include all athletes in the testing in order to play a winter high-risk sport.

Marion Spar expressed concern that kids may not be able to play if their parent objects to them testing. It is not fair to the child.

Sherri Gibson expressed that she is supportive of the resolution as presented at the October 21, 2021, meeting that was tabled.

Charles Peter suggested pool testing instead of every athlete each week when the school district is in a high transmission rate zone.

Daniel Grandinetti asked if masks were needed to play the sport. Jason Chevrier answered yes, for both basketball and wrestling, masks are required while participating.

Mary Yurista that we should all be on a level playing field. Jason Chevrier explained that local schools are requiring vaccinations to participate, others are requiring testing to participate.

Kurt Maier talked about last year's high-risk sports season and that there were no positive cases. This year we have vaccinations, the risk is lower than it was. We have to treat both vaccinated and unvaccinated the same.

Discussion ensued about the resolution and varying opinions were discussed.

Jason Chevrier, congratulated Charles Peter on his election to Town Supervisor.

A. **Sherri Gibson moved** to un-table the resolution tabled at the October 21, 2021, meeting, authorizing the district to participate in Winter High-Risk Sports, **Kurt Maier seconded, all present in favor.**

It is further declared, that any athlete wishing to participate in high risk winter sports must submit to weekly COVID-19 screening tests. Any athlete that refuses to be tested weekly will not be allowed to participate in any high-risk winter sport. Testing will continue throughout the season as long as testing supplies remain available."
