2. REPORTS

A. Discipline – Alyssa Sabbatino, Jacqueline Hill, Hillary Brochu, James Derby and Nicole Martin

Alyssa Sabbatino talked about emotional and behavioral stress that COVID has brought to students affecting their behavior. Administrators shared building level behavior data for different behaviors: Hands On: pushing, shoving, physical contact and Verbal: disturbance, disrespect, failure to follow the rules, as well as consequences for the various behaviors.

B. 2022-2023 Budget Update – Jason Chevrier and Brian Carey

Information was shared about the state budget process, changes to Aid, transfer to capital project limit increase, residential placement cost shift and retiree income waiver. Insurance rates came in lower than what was projected in Draft #2 of the budget, SFA contract negotiations an agreement has been reached, and Universal Pre-K. The proposed \$100K transfer to capital project for the high school gymnasium was outlined to be presented as part of the budget.

There was discussion about the search for a new high school principal.
