# 1. MEETING OPENING

A. President Shelley Palmer called the meeting to order at 6:00 pm.

B. Pledge of Allegiance to the Flag

C. Kurt Maier moved for approval of the Present Agenda, Angela Beber seconded, all present in favor.

D. Tylea Gebbie moved to approve the minutes of the February 15, 2024, regular meeting, Kurt Maier seconded, all present in favor.

# 2. REPORTS

A. Mid-Year Data Review - Mid-Year IReady data was shared for Reading and Math, showing a comparison of Fall 2023 and Winter 2024, Social Emotional Data by building showing a comparison from Fall 2022 to Fall 2023 as well as data from Winter 2023 and Winter 2024, Attendance Data showing absenteeism trends by month and day of the week, Discipline Data by building, by grade, as well as the types of discipline and consequences for infractions

# Marion Spar arrived at the beginning of the Mid-Year Data Review presentation.

B. 2024-2025 Budget Draft 2

1477 South Schodack Road Castleton, NY 12033 (518) 732-2297 Brian Carey and Jason Chevrier shared that the State Budget still remains unknown which creates difficulty preparing a budget, and further shared the knowns and unknowns that affect this draft of the budget, and changes both increases and decreases to the budget since the last meeting. There was discussion about fund balance use, tax cap percent and the change in taxes based on the different percentages. Propositions to appear on the ballot where discussed as well as a \$100,000 transfer to capital project that will be part of the budget.

Tylea Gebbie suggested a tax cap of up to 3%, Sherri Gibson said she agreed with 3%, Mary Yurista wanted to go out with 2.99%, Blake Kush said he would be comfortable going higher as long as there was clear direction about how it would be used, Kurt Maier expressed that even a small amount could hurt a family that is struggling, 2.95 up to 3% he could support, Marion Spar is comfortable with keeping it on the lower side 2.95-3%, Angela Beber agreed with 2.95-3%, Shelley Palmer expressed that if the board commits to put reserves back she is comfortable with up to 3%, we could be approaching shaky grounds in the future and should be careful with reserves.

Brian Carey explained the impact of a change to the exemptions should the board decide to move forward with the change to the existing exemptions.
